- 1.3 The details of work are available in the tender document which can be downloaded From website Central Public Procurement (CPP) Portal http://eprocure.gov.in/eprocure/app and the Tender is to be submitted online only on http://eprocure.gov.in/eprocure/app up to last date and time of submission of tender. Sale Of physical tender document is not applicable.
- 1.4 Bidding is open to all eligible Bidders meeting the eligibility criteria as defined. Bidders are to note and satisfy themselves that they fulfill eligibility criteria.
- 1.5 Technical evaluation shall be carried out by a Committee. The decision of the Director of Lighthouses and Lightships, Visakhapatnam in deciding the successful bidder shall be final and binding on the bidders.
- 1.6 The Bidder shall carefully read Eligibility Criteria & instructions to Bidders, Technical requirement & Scope of work, General & Special conditions of contract, all other documents in connection with the Tender. The Bidder shall quote his rates, keeping all above points in mind.
- 1.7 The Tender document comprises of Maintenance and repairs to Bheemunipatnam Lighthouse Station. The site location beside the road and sea the bidders are requested to visit the site before quoting. The Director, Directorate of Lighthouses and Lightships, Visakhapatnam reserves to himself the right of accepting the Tender. Bidder shall be bound to perform the same at the quoted rates.
- 1.8 Canvassing whether directly or indirectly, in connection with Bid is strictly prohibited. The Tenders submitted by the Bidders, who resort to canvassing, shall be summarily rejected.
- 1.9 Those Bidders whose near relatives are posted as accountant or as a Gazetted Officer in any capacity in the Directorate of Lighthouses & Lightships shall not be permitted to Bid. The prospective Bidder shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him, who are near relative to any gazetted officer in the DGLL or in the Ministry of Shipping. Any breach of this condition by the bidder shall render him ineligible. By the term 'near relative' is meant wife, husband, parents & grand parents, children & grandchildren, brothers & sisters, uncles, aunts & corresponding in laws.
- 1.10 The bidder shall disclose any payment made or proposed to be made to any intermediaries (agents etc.) in connection with the bid.
- 1.11 No Gazetted Officer of Government of India is allowed to work as a contractor without prior permission of the Govt. of India in writing for a period of two years after his retirement from government service. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of Govt. of India as aforesaid, before submission of the Bid or engagement in the contractor's service.
- 1.12 The Notice Inviting tender shall form the part of bid document.
- 1.13 The time is considered as the vital and most important part in the work. The contractors should access the time and they have to submit a plan for activity (Activity chart) and should adhere to the schedule submitted by them. The contractors who cannot complete the work in time or they are not confident are not required to participate in the bid.
- 1.14 No extension of time shall be given for submission of documents. The contractor should carefully upload ensure all the documents at the time of bidding. In case of non availability of any of the documents mentioned, the bid shall not be considered for technical evaluation.
- 1.15 (a) Heavy vehicles are not permitted up to the work site. The Heavy Vehicles are allowed up to the main gate of Lighthouse Station. However LMV's are allowed up to the work site.

- (b) If any damages occur during transportation/ execution to the pathway tiles/paver block/ plants etc. the same to be repaired by the contractor at his own risk and cost along with ongoing works.
- 1.16 The Director does not bind himself to accept the lowest or any other bid and reserves to himself the authority to reject any or all the bids without assigning any reasons. The Director also reserves the right to alter or modify or relax any criteria/condition of tenders if it considers expedient to do so, without assigning any reason. The Director also reserves the right to restrict the list of qualified contractors to any number deemed suitable by him, if too many bids are received satisfying the laid down criteria. The Director reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
