SPECIAL CONDITIONS

- 1. All the supplies upto the lighthouse premise shall be carried out as per latest version of relevant C.P.W.D. specifications/ relevant codes & specification of Bureau of Indian Standard and as per direction of Director of Lighthouses and Lightships, Jamnagar or his authorized representative.
- 2. The quantities mentioned in the tender schedule are tentative and may vary as per the requirement at the site. The decision of the Undersigned is final and binding on the contractor.
- 3. The supply shall be carried out and completed within a time period of **30_days** from date of receipt of work order .
- 4. All labours, materials, tools, plants, machinery, equipments, water, electricity, scaffolding, ladder, hoisting equipment,all duties/taxes/fees for transportation and any other things required for execution for work shall be arranged by the contractor at his own cost. Nothing shall be supplied by the **DEPARTMENT** for execution of work.
- 5. The contractor shall keep himself fully informed of all acts and laws of the central and Gujarat state, all local byelaws, ordinances, rules, regulations and all orders and decree of bodies or, tribunals having any jurisdiction or authority which in any way affect the conducts of the works. The work shall be carried out in the manner, complying in all respects with the requirement of all acts and laws of the central and Gujarat state, all local byelaws, ordinances, rules, regulations and all orders and decree of bodies or, tribunals having any jurisdiction or authority and nothing extra shall be paid on this account.
- 6. The contractor shall have to make supply of the materials with proper stacking at the site in good condition for transportation of labour and materials as well as inspection of work by the Director of Lighthouses and lightship, Jamnagar. Nothing extra shall be paid on this account.
- 7. The rates for all items of work unless clearly specified otherwise, shall include the cost of all labour, materials, transportation, any taxes/Duties/Fees and all other inputs involved in the execution of the items.
- 8. Unless otherwise provided in the schedule of quantities the rates tendered by the contractor shall be all-inclusive and shall apply to all heights, depths, leads and lifts.
- 9. All tools, plant and machinery provided by the contractor shall, when brought to the site, be deemed to be exclusively intended for execution of this work and the contractor shall not remove the same or any part thereof without the consent of the Director of Lighthouses and Lightships, Jamnagar.
- 10. All arrangements of establishments, storage of materials, watch and ward of stores and full security of sites, police permission, permits, license, appropriate vehicles for transportation etc. shall have to be made by the contractor at his own cost and nothing extra on this account shall be paid. The Director or his authorized representative may ask the contractor to dismiss or remove from the site of work any person or persons in the contractor's employee upon the

work who may be incompetent or misconduct himself and the contractor shall forthwith comply with such requirements.

- 11. The Contract shall be governed by the Law of India. Law suits and other proceedings arising out of or in conjunction with this work shall be instituted in courts of law of Jamnagar (Gujarat).
- 12. The Contractor shall be deemed to have satisfied himself as to the correctness and sufficiency of the Contract Price. The contract price covers all the Contractor's obligations under the contract and all things necessary for the proper execution and completion of the works.
- 13. The Contractor shall take all reasonable steps to protect the environment (both on and off the site) and to limit damage and nuisance to people and property resulting from pollution, noise, dust, gases, fuel and other results of his operations.
- 14. All royalties, sales tax ,purchase tax, turnover tax or any other taxes, duties and any other levies etc. shall be paid by the Contractor and the Director will not entertain any claim whatsoever in respect of the same.
- 15. Any notice to the contractor shall be deemed to be sufficiently served if given or left on writing at his usual or last known place of abode or business or at site.
- 16. The Price quoted by the tenderer and accepted by the Director shall hold good till the completions of works and no additional claims shall be admissible on account of any price variation or fluctuation in the market rates due to any reasons.
- 17. While execution of the work site any damage done to the property, building etc. by the contractor has to be set right by himself at his own cost.
- 18. The contractor shall be required to produce samples of all materials sufficiently in advance at his own cost to obtain approval of the Director. This approved sample shall be displayed at site of work and preserved till completion of the work. The materials to be used in the actual execution of the work shall strictly conform to the quality of samples approved. In case of any variation, such materials shall be liable to rejection.
- Any error in description, quantity or rate in Schedule of Quantities or any omission there from shall not vitiate the contract or release the Contractor from the execution of the whole or any part of the works comprised therein according to drawings and specifications or from any of his obligations under the contract.
- 20. It shall be accepted as a condition of the contract that payment of the final bill accepted by the contractor shall constitute a full & absolute release of the Director from all further claims by the contractor under the contract.
- No advance payment shall be paid on any account by the department.
- Earnest money deposit: The Earnest money deposit of the successful Bidder shall be adjusted as part of security deposit in running account bills.
- Income Tax: The Income tax as applicable along with surcharge (2% +SC) of value of work will be deducted in each running account bill during the progress of work. The statement of deduction of Income tax {Form-16(A)} will be issued to the contractor at the end of every financial year by the Directorate.

24 Sales Tax, Service Tax etc.: The sales tax, service tax, VAT etc. connected with the work for the purchase of materials etc. are to be borne by the contractor.
