- (ii) Original EMD should reach to this office up to 07 days from date of opening of technical bid. The details of the Demand Draft/Bank Guarantee, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time, otherwise the uploaded bid shall liable to be rejected.
- (iii) EMD is exempted for micro and small firms registered with NSIC/MSME. However, bidder has to submit the NSIC/MSME certificate, mentioning the services of maintenances of Diesel Generators therein to avail the same.

- (iv) The details of work are available in the tender document which can be downloaded from website Central Public Procurement (CPP) Portal <https://eprocure.gov.in/eprocure/app> and the bid is to be submitted online only on or before the last date and time of submission of tender. Sale of physical tender document is not applicable.
- (v) The date of pre-bid meeting and date of tender opening shall be extended to next working day in case of any unforeseen event like strike, bandh or any natural calamities etc.
